#### EXETER CAMPAIGN FOR NUCLEAR DISARMAMENT

- 1. The first central meeting of Exeter CND was held at the Oddfellows Arms at 7-30 p.m. on 17 November 1980.
- 2. Attendance. 51 members attended, the sum made up of representatives from each area group, working groups A and B, and observers.
- 3. Apology for Absence. Mrs. Saxon Spence.
- 4. Election of Chairman of the meeting. Dr. P.J. Shephord was elected Chairman of the meeting.
- 5. Acting Secretary's Report. Rita Thomson reported:
  - i) That there were sufficient funds to cover costs of the "Public Information" leaflet.
  - ii) That membership stood at 167.
  - iii) That National CND was aware of the confusing relations (or evident lack of relations!) between local groups and the national body, and intended to rationalise the situation.
- 6. Wording of the "Public Information" leaflet. The Chairman reported on the work of Working Groups A and B, and distributed copies of the draft for consideration by the meeting. The main objections raised were:
  - i) That it contained too many difficult words and phrases.
  - ii) That it appeared too anti-American.
  - iii) That there should be more information on the tear-off slips.
    - iv) That the request for money should be omitted.

After discussion, votes were taken as follows:

- a) On the understanding that Working Group A would simplify the wording and take into consideration written suggestions for amondment, that the contents of the leaflet be approved:
- 46 for 3 against 2 abstentions
  b) That the wording of the tear-off slip be amended, but
  the request for money be retained:

35 for 6 against 10 abstentions

c) That the format of the leaflet be approved: carried unanimously.

It was further resolved:

- d) That the cost of £336 for 40,000 leaflets be accepted.
- e) That distribution day be Sunday 7 December 1980.
- 7. <u>National Conference</u>. The Acting Secretary undertook to provide a written report on relevant issues discussed at the Leeds

- 8. Agenda for Next Meeting. It was agreed that the constitution and organization of Exeter CND should be the main business.

- 9. Any Other Business.
  - i) Tickets for The War Game would be distributed after the meeting. There were to be two public showings of the film at 7-30 and 9 p.m. on 8 December in the Bedford Room of the Barnfield Theatre. It was heped that there would be an earlier showing, for members, on 2 December. A proposal by Peter Frings that £40 be made available for posters was accepted.
  - ii) Sir Richard Acland's proposal that the Friends' Meeting House would be a more suitable venue for meetings was discussed. The fact that smoking is not permitted there counted less in the turning down of the proposal than the fact that it is only available on Friday and Saturday (If that interpretation is contentious, ignore it...)

  - b) It has a minimum of ten supporters
  - c) It includes among its meetings every year and annual general meeting to which all its members and supporters are invited with at least two weeks notice, and that at the same, or other general meeting, deals with business relating to CND annual conference and elects its officers of whom the secretary and chairperson at least must be members of the national campaign.
  - d) It contributes a yearly sum to the national campaign, this sum to be determined by the National Council."
